18 The Honorable Brian J. Lamb and the Honorable Dean T.  
19 Stout, sitting judges of the above-entitled Court, having met  
20 and conferred regarding the assignment of judicial officers,  
21 having agreed upon the same, and good cause appearing therefore,  
22 IT IS HEREBY ORDERED that the following judicial assignments  
23 shall be effective Monday February 2, 2009, and remain in effect  
24 pending further order of this Court:

25 The Hon. Dean T. Stout shall continue to serve as the  
26 Presiding Judge of the above-entitled Court and the Hon. Brian  
27 J. Lamb shall continue to serve as the Assistant Presiding Judge  
28 of the above-entitled Court. The Hon. Dean T. Stout has

1 heretofore been appointed by the Chief Justice as Presiding  
2 Judge of the Appellate Division of the above-entitled Court, and  
3 the Hon. Brian J. Lamb has been assigned as a Judge of said  
4 Appellate Division.

5 The Hon. Dean T. Stout shall serve as the Presiding Judge  
6 of the Juvenile Court, and the Hon. Brian J. Lamb is also  
7 assigned as a Judge of the Juvenile Court.

8 Both the Hon. Brian J. Lamb and the Hon. Dean T. Stout are  
9 assigned to hear ex-parte applications for civil protective  
10 orders, including Emergency Protective Orders; Penal Code §  
11 136.2 Criminal Protective Orders; applications for arrest and  
12 search warrants; review Probable Cause Declarations; and  
13 applications for increase in bail.

14 Except as provided herein, all adult criminal cases,  
15 infractions, misdemeanors, and felonies are assigned for all  
16 purposes to the Hon. Brian J. Lamb. As provided by the  
17 provisions of Welfare & Institutions Code § 603.5 and this  
18 Court's Standing Order No. 03-014, filed October 6, 2003, Judge  
19 Lamb is assigned for all purposes to hear all juvenile traffic  
20 infractions. Judge Lamb is also assigned for all purposes to  
21 hear all Petitions for Writs of all types and nature, filed in  
22 the above-entitled Court, arising out of, or pertaining to,  
23 criminal cases. The Hon. Dean T. Stout is assigned to the Inyo  
24 County adult felony Drug Court. Judge Dean Stout is assigned to  
25 preside over the regular Monday Southern Inyo traffic infraction  
26 court trial calendars.

27 The Hon. Brian J. Lamb is assigned for all purposes to all  
28 limited and unlimited civil cases, and to hear all Petitions for


1 Writs, filed in the above-entitled Court, of all types and  
2 nature, arising out of, or pertaining to the aforesaid civil  
3 cases.

4 Except for the aforementioned juvenile traffic infractions,  
5 the Hon. Dean T. Stout is assigned for all purposes to all  
6 unlawful detainer, family law, parental relationship, probate,  
7 small claims, L.P.S. Conservatorship, juvenile delinquency,  
8 adoption, and juvenile dependency cases. Judge Stout is also  
9 assigned for all purposes to hear all Petitions for Writs, of  
10 all types and nature, filed in the above-entitled Court, arising  
11 out of, or pertaining to, the aforesaid types of proceedings.


