INSTRUCTIONS FOR CREDIT CARD PAYMENTS USING THE *OFFICIAL PAYMENTS* WEB-SITE

Abstract

These instructions provide a step-by-step procedure using the Official Payments web-site in order to pay court fines and fees to the Superior Court of California, County of Inyo. The following pages are actual screen shots of the Official Payments web-site including instructions on how to properly fill out each page.

Official Payments Corporation charges a convenience fee to use this service to make the payment. This charge is **payable to Official Payments** and **is separate** from the primary obligation you will pay the Court. If your case has been referred for collections to the Franchise Tax Board or to Alliance One, you must make your payment **directly** to those collection agencies and **not** through this credit card process. If your case has been referred to either of these collection agencies, and you pay the Court by credit card, your payment may be returned to you. The credit card fee charged is non-refundable.
